

### Polling - Royal Commissions

### September 2018

### **Key Results**

The Australia Institute surveyed a nationally representative sample of 1,449 Australians about attitudes about four recent Royal Commissions.

- Misconduct in the Banking, Superannuation and Financial Services Industry (the "Banking Royal Commission")
- Institutional Responses to Child Sexual Abuse (the "Royal Commission into Child Abuse")
- Trade Union Governance and Corruption (the "Trade Union Royal Commission")
- The Murray-Darling Basin

The Murray-Darling Royal Commission was announced by the South Australian government. The other three Royal Commissions were announced by the federal government.

The survey first asked Australians how much they had heard about each of the Royal Commissions.

Most Australians have heard about the Banking Royal Commission (85%) and the Royal Commission into Child Abuse (75%).


- Half of Australians (48%) have heard "a lot" about the Banking Royal Commission
- 29% have heard "a lot" about the Royal Commission into Child Abuse

Almost half of Australians (47%) had heard about the Trade Union Royal Commission, although only 9% have heard "a lot" about it.

 Almost as many Australians (46%) have heard "nothing" about the Trade Union Royal Commission as have heard about it One-third of Australians (35%) have heard about the Murray-Darling Basin Royal Commission, including 5% who have heard "a lot" about it.

 A majority of Australians (56%) have heard "nothing" about the Murray-Darling Basin Royal Commission

The survey asked participants what they thought the main reason for each Royal Commission being established was.

Australians overwhelming thought that the Royal Commission into Child Abuse was established "to pursue justice and fairness" (71%), and almost half thought the same thing about the Banking Royal Commission (49%).

- 38% of Australians thought the Trade Union Royal Commission was established mainly "to pursue justice and fairness"
- 27% thought the Murray-Darling Basin Royal Commission was established mainly "to pursue justice and fairness"

Australians were more likely to think that "public pressure from voters" was the main reason for the Banking Royal Commission to be established (34%) than for the Royal Commission into Child Abuse (17%) or the Murray-Darling Basin Commission (20%) to be established.


 Only 12% of Australians thought "public pressure from voters" was the main reason the Trade Union Royal Commission was established, the lowest response for any Royal Commission

Australians were more likely to think that the Trade Union Royal Commission was established "to attack political opponents" (31%) than thought that about the Royal Commission into Child Abuse (4%), the Banking Royal Commission (8%) or the Murray-Darling Basin Royal Commission (10%).

For most responses, Australians of different demographics and from across the political spectrum responded similarly. The exception is the Trade Union Royal Commission, which attracted more polarised responses.

- 39% of men thought that the Royal Commission was established mainly "to attack political opponents", compared to only 24% of women
- More Labor voters (38%) and Greens voters (34%) thought that the Trade
   Union Royal Commission was established mainly "to attack political opponents"
   than thought it was established mainly "to pursue justice and fairness" (Labor
   32%, Greens 31%)

Thinking about these Royal Commissions, what do you think was the main reason why they were established?




Respondents were asked whether the reputations of churches, banks, trade unions and the Federal government had fared better or worse than expected due to the Royal Commissions.

Twice the number of respondents said banks and financial service providers fared worse than expected, as said Trade Unions had fared worse (30%).

- A majority (61%) said banks and financial service providers had fared worse than expected, followed by Churches (51%), the Federal Government (36%) and Trade Unions (30%)
- Respondents were most likely to say the reputation of Trade Unions had fared as expected (41%), and least likely to say banks and financial services had fared as expected (21%)
- Few thought any of the organisations had fared better than expected, but respondents were least likely to say Churches had fared better (7%, compared to 10% for Banks and financial service providers, Trade Unions and the Federal Government).

Compared to what I expected, their reputation has fared




# Respondents were then asked to compare the outcomes of the Banking Royal Commission compared to the Trade Union Royal Commission.

Overwhelmingly, respondents thought the Banking Royal Commission had uncovered more wrong doing, was more important for the most Australians and would lead to more lasting change than the Trade Union Royal Commission.

- 70% thought the Banking Royal Commission had uncovered more wrong doing compared to 11% for Trade Union Royal Commission
- Two thirds (65%) thought the Banking Royal Commission was more important for the most Australians, compared to 16% for the Trade Union Royal Commission
- Half (55%) thought the Banking Royal Commission would lead to more last change compared to the 12% who thought the Trade Union Royal Commission would.

#### Method

The Australia Institute conducted a national survey of 1,449 people 3 August and 15 August 2018, online through Research Now, with nationally representative samples by gender, age and state and territory.

Results are shown only for larger states.

Voting crosstabs show voting intentions for the lower house. Those who were undecided were asked which way they were leaning; these leanings are included in voting intention crosstabs, but results are also shown separately for undecideds. "LNP" includes separate responses for Liberal and National. "Other" includes Centre Alliance, United Australia Party and Independent/Other.
