Polling - Ending native forest logging across Australia

April 2024

Key results

The Australia Institute surveyed a nationally representative sample of 1,008 Australians about an end to native forest logging on public land.

The results show that:

- Seven in 10 Australians (69%) support an end to native forest logging on public land across Australia, including 37% who strongly support an end.
- Only one in five (19%) oppose an end to native forest logging across Australia.
- There is majority support for ending native forest logging across Australia in Western Australia (71%), NSW (70%), Victoria (66%) and Queensland (68%).
- There is majority support for ending native forest logging on public land across Australia from all major voting intentions, with highest level of support from Labor voters (79%), followed by Greens voters (76%), Coalition voters (62%), One Nation voters (61%) and Independent/Other voters (57%).




Figure 1: End native forest logging across Australia, by state

Respondents were told:

Victoria and Western Australia ended native forest logging earlier this year.

They were then asked if they support or oppose an end to native forest logging on public land across the rest of Australia.

Support for ending native forest logging on public land across Australia is high across voters for all parties.

- Labor voters are the most supportive (79% total support, 42% strong support).
- Greens voters had the second highest level of support (76% total support), and the highest level of strong support (54%).
- Three in five Coalition voters (62%) and One Nation voters (61%) support ending native forest logging on public land across Australia, more than twice as many as oppose (26% for both).
- Independent/Other voters are least supportive, but even among them there is 57% total support (with 37% strong support), compared to 20% opposed.




Figure 2: End native forest logging in Australia, by voting intention
