



Polling - Australian attitudes to ACT policies


Key results

In 2019, the Australia Institute published *Canberra: Laboratory of democracy,* which described innovative, politically controversial policies from the Australian Capital Territory that were popular across the country.

In May 2024, the Australia Institute once again surveyed a nationally representative sample of Australians about whether they support, for their own state or territory, each of those 10 policies.

The results show that most of these policies have widespread support across Australia.






Nine of the 10 policies attracted majority support.

- Spending on **programs to reduce youth crime and incarceration** is the most popular ACT policy, supported by 84% of Australians.
- The practice of "salt and peppering" public housing throughout suburbs, including new developments, is supported by three in four Australians (75%).
- Seven in 10 Australians (71%) support an **exclusion zone around booths on election day** (where people cannot hand out electoral material).
- Seven in 10 Australians support **100% renewable energy** (71%), including most Labor (80%), Coalition (54%), Greens (91%) and Independent/Other (69%) voters.
- Two in three Australians (64%) support allowing people at music festivals to test the contents of recreational drugs for poisonous substances (pill testing).
 Support is similar across the large states, with 66% of WA, 64% of NSW and Queensland and 60% of Victorian residents in support.
- Three in five Australians (60%) support removing stamp duty and replacing it with an annual tax based on property value.
 - Support for a stamp duty for land tax swap is highest among those aged 18–29 (at 70%), but there is majority support even among those 60 and older (54%).
 - Across the four large states, a majority support a stamp duty for land tax swap (59% in NSW, 58% in Victoria, 56% in Queensland and 73% in WA).
- Over half of Australians (54%) support a public holiday for Reconciliation Day to share Indigenous cultures and history, and explore reconciliation in Australia.
 - A majority of NSW residents, Victorians and Queenslanders support a public holiday for Reconciliation Day (56%, 53% and 56% respectively).
 - Among the large states, only in WA are more opposed than supportive (48% vs 39%) of a public holiday for Reconciliation Day.
- Over half of Australians (52%) support **decriminalising cannabis for personal use**, compared to one in three (36%) who oppose.
- The ACT's **ban on outdoor billboard advertising** is the only policy where more Australians were opposed than supportive (49% vs 37%).

The Australia Institute first asked Australians whether they supported or opposed innovative policies from the ACT in 2018. The results were described in more detail in *Canberra: Laboratory of democracy.*¹ There is little change in overall levels of support since 2018, and most changes on individual policies are within the sum of the margins of error of the two polls.
